Note on shared mailboxes

ECB-UNRESTRICTED

- Shared mailboxes will not receive written procedures or information items anymore as they cannot be added in DARWIN-ASTRA groups.
- The reason for this is that a security issue might arise as shared accounts do not disclose who is behind them. Only nominal users can be added in such groups.

Way forward

- The automated Written Procedures and Information Items tool will be fully operative from the beginning of 2022.
- A kind reminder to Central Banks that have not yet requested the relevant role through ESCB IAM to please request it as soon as possible.
