#### TIPS R2024 – Status of other CRs candidate for TIPS R2024.NOV

Current status of the CRs still candidate for inclusion in TIPS R2024.NOV:

- TIPS-0064 (Adaptation of TIPS for the settlement of cross-currency transactions (based on OCT Inst scheme)
  - DA requested on: 9 January 2024
  - > DA expected delivery date: 8 March 2024 (might vary should critical issues emerge during the analysis)
  - > This CR is considered as candidate for TIPS R2024.NOV because of its strategic relevance and the technical synergies with TIPS-0068.
  - > To possibly include it in the scope of TIPS R2024.NOV, the Feasibility Assessment exercise will have to be performed (and confirmed) again and the necessary formal steps with the TIPS governance will have to be taken.
- TIPS-0066 (TIPS Pricing Invoicing Enhancements)
  - DA delivered on: 18 December 2023
  - This CR is allocated to TIPS R2024.NOV because it reduces the operational risk connected to the current procedures of manual corrections of the invoices triggered by TIPS-0057.

#### TIPS R2025 – Way forward

As a result of today's meeting, the TIPS CG members are invited to take note that, during their last meeting, the TIPS WG members approved the allocation of the following Change Request to the scope of the TIPS R2025.NOV:

□ TIPS-0028-URD (Rule-based liquidity transfer orders between MCA and TIPS DCA)

At their meeting on 24 January 2024, the T2-WG officially confirmed the allocation of T2-0067-SYS "CLM changes to accommodate T2S rule based LT" to T2 R2025.NOV.





### Other potential scope items

#### **Norges Bank onboarding:**

- ☐ It is not yet known when the NOCB onboarding will take place, or how many changes will have to be implemented.
- ☐ The idea would be to follow the same approach already followed with other TIPS onboardings, i.e. group the changes over possibly more CRs, which could be ideally distributed over two TIPS releases.
